- Duration** : 1 Year
- Sanctioned Intake** : 30

## Diploma in Intellectual & Property Rights (DIPR)

- Eligibility** : Graduation or Equivalent from a Recognised University
- Admissions** : Admission in all the programs of DIPR is done by Gandhinagar University, Based on Merit
- Tuition Fees** : Rs. 35,000/- per Semester
- Duration** : 1 Year
- Sanctioned Intake** : 30

## PhD (Law)

The eligibility for the PhD course, the candidate must have passed a Master's degree with 55%. If required the University may conduct the entrance exam, a group discussion, and an interview.

The PhD registration portal shall be launched at the Gandhinagar University portal. Depending upon the availability of the Supervisors, the admission shall be considered.
