Eligibility

- Candidates shall have, a Master's degree or a professional degree declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade or an equivalent degree from a foreign educational Institution, accredited by any Assessment and Accreditation Agency.
- As per New Education Policy (NEP) 2020 for implementing the concept of Interdisciplinary / multidisciplinary education in Ph.D. Program, a Certificate from the Parent Institution/University stating equivalent credit weightage has been assigned to the students for the credits earned in the MOOCs opted by him/her through SWAYAM platform in the credit plan of the programme offered by the Parent Institution/University; wherein it should be categorically specified that MOOCs opted by any student has been allowed only for 20% of the total courses offered in a particular program in a semester by the Parent Institution/University (as per UGC Guidelines for MOOCs).
- Fellow members of the Chartered Accountants of India (CA) or Institute
 of Costs and Works of India (ICWA) or Company Secretary of India (CFA)
 with 55% marks at graduation level and with 5 years of research
 experience after graduation (only for the Faculties of Law, Management
 and Humanities and Social Sciences).
