## Master of Valuation (Real Estate) (M.Val.)

- Eligibility** : Graduation B.Com., B.Sc., B.E., B.Tech., B.Arch., B. Planning or Equivalent from a Recognised University
- Other Eligibility Criteria** : Candidate should be graduated in above stated subjects and have Bachelor Degree Examination preferably in Mathematics, Statistics, Economics and allied subjects of this University or an examination recognized as equivalent thereto
- Admission** : Admission in all the programs of M.Val. is done by Gandhinagar University, Based on Merit
- Tuition Fees** : Rs. 50,000/- per Semester
- Duration** : 2 Years
- Sanctioned Intake** : 60

## Master of Valuation (Plant & Machinery) (M.Val.)

- Eligibility** : Graduation B.Com., B.Sc., B.E., B.Tech., B.Arch., B. Planning or Equivalent from a Recognised University
- Other Eligibility Criteria** : Candidate should be graduated in above stated subjects and have Bachelor Degree Examination preferably in Mathematics, Statistics, Economics and allied subjects of this University or an examination recognized as equivalent thereto
- Admission** : Admission in all the programs of M.Val. is done by Gandhinagar University, Based on Merit
- Tuition Fees** : Rs. 50,000/- per Semester
- Duration** : 2 Years
- Sanctioned Intake** : 60



## PhD (Valuation Studies)

The eligibility for the PhD course, the candidate must have passed a Master's degree with 55%. If required the University may conduct the entrance exam, a group discussion, and an interview.

The PhD registration portal shall be launched at the Gandhinagar University portal. Depending upon the availability of the Supervisors, the admission shall be considered.
